**Subject: 2024 Grant Funded Projects** 

# Recommendation(s)

1. That Council approve \$773,887 of expenses, funded from various governments, government agencies, and non-profit organizations for the following projects:

- a. Kwantlen Interpretive Signage \$70,000
- b. Indigenous Carving \$5,500
- c. Celebrate Canada Event- \$5,000
- d. Housing Legislation Implementation \$345,952
- e. Firesmart and Fuel Management Program \$190,235
- f. Community Resiliency Investment (CRI) Program \$54,200
- g. Housing Innovation Day \$10,000
- h. Emergency Disaster Management Program- \$48,000
- i. Mission Active Support Table (MAST) Program \$15,000
- j. Stream Mapping \$30,000; and
- 2. That the City's 2024 2028 Financial Plan be amended accordingly.

#### **Purpose**

The purpose of this report is to have Council formally approve adding the projects with grant funding into the City's 2024 – 2028 financial plan to ensure compliancy with Section 173 of the *Community Charter*.

#### **Background**

During the year the City is often successful in obtaining grants from senior levels of government and non-profit organizations for a number of different projects. When grant approvals happen outside of the budget preparation season, the City is required to amend its financial plan to adhere to Section 173 of the <u>Community Charter</u> which states:

### Limit on expenditures

173 (1) A municipality must not make an expenditure other than one authorized under subsection (2) or (3).

- (2) A municipality may make an expenditure that is included for that year in its financial plan, so long as the expenditure is not expressly prohibited under this or another Act.
- (3) A municipality may make an expenditure for an emergency that was not contemplated for that year in its financial plan, so long as the expenditure is not expressly prohibited under this or another Act.

## **Discussion and Analysis**

All expenditures of a municipality, regardless of funding source, require Council approval as stated in Section 173 of the *Community Charter*.

The grant projects listed in the table below are consistent with the City's operations and Council's strategic (focus) goals. Staff are requesting Council's approval to include these expenditures in the City's 2024 – 2028 financial plan.
