Subject: Coffee with Council Sessions

Recommendation(s)

This report is provided for information only, no action by Council is required.

Purpose

The purpose of this report is to outline the "Coffee with Council" sessions (Sessions) and confirm that the concept meets Council's expectations.

Background

Council has made it clear that it is very interested in maximizing the opportunities for the public's input. At its December 6, 2021 meeting, Council resolved to hold Sessions starting in 2021. This report outlines a plan for the Sessions and seeks to confirm Council's expectations are met.

Discussion and Analysis

The Sessions would be held monthly at small local coffee shops, including but not limited to Grab-a-Java, The Penny, the Energy Wisdom and Tea Lounge, English Tarts and Amazi with advance permission from the owners. Sessions would vary in time based on opening hours of each coffee shop with some being held on weekday evenings and some on Saturday mornings or afternoons.

Staff are suggesting that 3 Councillors attend each Session with the schedule below based on alphabetical order of Council. It is important to ensure that less than 4 Councillors attend each session to avoid the chance that a legal Council meeting is convened. Councillors can swap Sessions as needed.

Attending Councillors can speak with the CAO after each session to determine whether a follow-up item has significant enough staffing or financial requirements that a Council resolution is required before actioning.
